Dues invoices mailed this week

It's that time of the year-Association dues invoices are being mailed this month, but that's not the only administrative task departments must complete in order to remain in Good Standing with the Association.

The due date for your department's Association membership dues invoice is **January 1, 2024**. In addition, **Voting Members must be selected by January 1, 2024**, in accordance with the by-law changes voted and approved by your delegates at the 2020 Fire-Rescue Conference.

Forms 206 and 207 are due midnight on January 31, 2024 on the Association's Member Management System (MMS). Your department's Profile & Statistician Report Form 101 should also be completed within the MMS. All forms must be completed no later than midnight January 31, 2024, for your department to remain a member in good standing with the Association. If we do not receive the forms by the deadline, your department will jeopardize their Firemen's Insurance & Inspection Fund distribution and the loss of Association Member Benefits.

Women in Fire awarded \$1M to address women's healthcare issues in the fire service

Press Release from Women in Fire: On September 13th, <u>Women in Fire</u> was awarded \$1,032,209 in Fiscal Year 2022 Fire Prevention and Safety grant funds from the Federal Emergency Management Agency.

The lack of recommendations for firefighters regarding reproductive health from conception to lactation and return to work is alarming. 25% of women firefighters report their fire department does not have a policy addressing pregnancy or maternity leave; this is unacceptable.

Some of the specific objectives of this grant will include:

- Reproductive Health Toolkit
- Mentorship Program
- Continued dissemination of existing firefighter-specific curriculum focused on improving DEI in the FS nationally
- Further increase the reach of this training by adding these developed training courses to an online learning management system (LMS)

This project has the potential to improve health and safety by increasing access to pertinent healthcare information, assisting in policy development, increasing diversity in the fire service, and enhancing the recruitment and retention of women and minorities.

National fire service organizations recognize a need for reproductive health policies and resources for men and women to promote better inclusion and signal diversity, equity, and inclusion support. Women in Fire will work with NDRI-USA, the Center for Fire, Rescue, and EMS Health Research (CFREHR), the National Volunteer Fire Council (NVFC), and the Beltane Guild to carry out the goals and objectives of this award.
