The IRS has ruled that Volunteer Firefighters are employees, if you have 50 or more you will have to offer Health Care. The NVFC is proposing legislation on this; we need to support preventative legislation.

Joint Council has decided to have 3 conference calls a year on a quarterly basis and 1 face to face meeting with all parties' executive boards. The meeting will be held in January of each year in conjunction with the Fire Service Improvement Conference.

The Fire Department Fitness Challenge has 7 departments signed up so far. In January the Safety & Health Committee will announce an individual challenge.

Jason Pope gave an update on new items to look for on the [scfirefighters.org](http://scfirefighters.org) website.

The 2014 Fire-Rescue Conference schedule is almost complete. We have a lot of local and national instructors. We have a new activity this year with Wonderworks the first 400 people can attend Wonderworks at Broadway at the Beach on Friday night for \$5.00 per person and \$10.00 for a family meal.

Joe Palmer gave an update on Palmetto Resource Solutions. This company will be a company created under SCFIS. This company will provide benefits for other associations such as website, database and other benefits to include insurance.

The Planning & Goals Committee proposed the new mission and guiding principle statement for the South Carolina Firefighters' Association Executive Committee to review.

- 2) Securing the best benefits to our members in keeping whole their behavioral, physical, and financial well-being; and,**
- 3) Fostering a collaborative working environment where the larger collective of our fire service wisdom and skills can come together to plan and shape the future of our profession through training, education, and advocacy.”**
